Pierce County COVID Testing Site-3003 107th St. S., Lakewood, WA 98499. It sits back off 112th, once you turn onto 107th, you'll see signs. Hours 10:30 am-5:30 pm. This place is recommended since you'll get results faster. You should get tested if you experience fever, chills, cough, shortness of breath, fatigue, muscle pain, headache, loss of taste or smell, sore throat, stuffy or runny nose, nausea, vomiting, diarrhea **or if you were close to a person with COVID-19 or attended a gathering with many people.**
